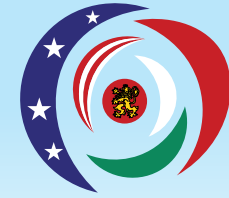

Starting at **\$899**/year

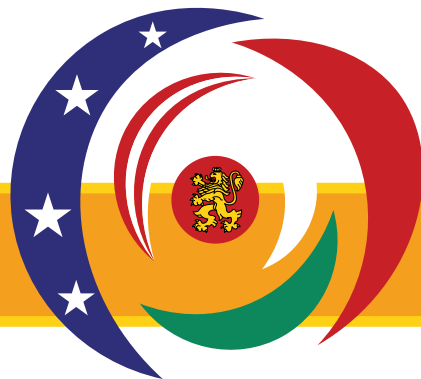
One representative of a business entity may join as a Member in his or her name.
